II. Manufacturing Defects:

- DELAMINATION
- DEFECTIVE MILLING
- CORE DEFECTS
- DIMENSIONAL INSTABILITY
- LOCKING MECHANISM FAILURE

III. Wear Warranty:

The decorative wear layer will not wear through under normal residential traffic.

IV. Waterproof Warranty:

Warranted against topical moisture damage resulting from normal household spills and routine wet cleaning when properly installed and maintained.

V. Structural Integrity:

The flooring will not crack, split, or delaminate under normal indoor conditions.

VI. Dent Resistance:

Warranted against permanent indentation from normal household use and approved light commercial applications.

VII. Conditions Of Warranty:

- Flooring must be installed indoors only.
- Installation instructions must be followed.
- Subfloors must meet published preparation requirements.
- Appropriate expansion spacing must be maintained.
- Indoor climate conditions must be maintained between 65°F and 85°F.

VIII. Warranty Exclusions:

- Improper installation
- Improper maintenance
- Flooding or hydrostatic pressure
- Excessive moisture originating below the subfloor
- Construction traffic
- UV fading or discoloration
- Chemical damage
- Rolling load damage
- Improper furniture protection
- Acts of God

IX. Claim Procedure:

Claims must be submitted through the original dealer or distributor. Proof of purchase, photographs, and access for inspection may be required. Claims must be submitted within thirty (30) days of discovery.

X. Limitation Of Liability:

Spectrum's sole obligation under this warranty shall be limited to repair or replacement of defective product. Spectrum shall not be liable for incidental, consequential, or special damages.
